3.1 Activation of a new certificate for Timestamping

The new timestamping server certificate will be activated on **7/05/2017**. (Reason: new hardware).

3.2 Mediprima

- For the extension of Mediprima to physicians: 2 new webservices will be made available.
- The Mediprima Consultation Web service New version of the Carmed consultation service initially planned for hospitals only. This new service clarifies, among other things, the comment field.
- The Mediprima Tarifs Consultation Web service New service initially intended for physicians .It is a service similar to the tarification service (MycareNet) but specifically intended to cover the persons covered by Mediprima (by agreement with The CPAS).
- These two services are to be integrated in conjunction with MycareNet's electronic billing service.
